C About the School

Since the establishment of WCS in 1995, the school has established campuses located in various regions of Sacramento. Approximately 25 classes in Mandarin and Cantonese are now offered. There are 24 teachers and about 350 students. The class size ranges from 10 to 25 students, and the assignment of students to classes is based on the language level assessment.

D Activities

Activities include: parent conference on the first day of class, the class picture day, Christmas celebrations, Chinese zodiac poster contest, Lantern Parade, parent-teacher conferences, Mother's Day celebration, and the graduation ceremony.

E Activities During Summer

1. Chinese Culture Camp for Children: a week long summer program, which is held annually in mid July at McClatchy High School.
2. Talent Classes: Classes for dances, arts & craft, and conversational skills improvement may be offered, based on demand.

F Instructional Materials

1. The current text book, "Ni Hao", focuses on conversational Chinese including listening, speaking, reading and writing, with a balance in both the language skills and cultural knowledge, and prepares student to transit to the AP Chinese curriculum.
2. Students may purchase the text books from the WCS office or elsewhere. Both new and used text books are acceptable. However, students must use a new "Ni Hao" workbook. Photocopying of the text books and work book is strictly prohibited.
